

## Competition

### General conditions of participation

By entering your e-mail address on a webpage of Senectute beider Basel, you agree to register as a user and allow Pro Senectute beider Basel to store all data for the duration of the competition, and beyond this period, for marketing purposes.

The prize cannot be paid out in cash or exchanged. No correspondence will be entered into regarding the raffle. Winners will be notified personally. Recourse to the courts is not permitted.

#### 1. Eligibility

In order to participate in draws, all personal information must be accurate.

#### 2. Execution and processing of draws

- The draws are random. The conditions of the draw are entirely the responsibility of Pro Senectute beider Basel.
- The terms of delivery of the prizes shall be determined by Pro Senectute beider Basel.
